



地熱能源為利用地球核心深處產生的熱產生熱能或是電力,為一種乾淨的再生能源,相比於具有間歇性的太陽能或是風能之再生能源,地熱能能夠穩定供電作為基載電力。在火山型地熱能源探勘中,地熱鑽井所取出的岩心樣本可藉由多種分析方法得到地下資訊,例如溫度、流體酸鹼值、儲集層或是蓋層。本次展覽中展示數個不同深度的岩心栓樣本,其岩性皆為安山岩質,並依產狀區分為火山角礫岩或火山熔岩流,再藉由分析得到其物理和化學特性,進一步評估其地熱潛能。此外,岩心樣本含有方解石脈的出現,指示其深度區間流體為中性或是弱酸性,證實台灣北部大屯山火山型地熱地下存在弱酸性儲集層之可能性。

Geothermal energy is a clean renewable resource that generated heat deep in the core of the Earth to produce thermal energy or electricity. Compared with intermittent renewable energy sources such as solar energy or wind power energy, geothermal energy can provide stable energy as base load power. During the exploration of volcanic geothermal energy, core samples taken from drilling wells can be used to obtain plenty of underground information, such as temperature, fluid pH, reservoirs or caprocks through a variety of analysis methods. In this exhibition, we display several core samples from various depths, all characterized by andesitic rock. They are further classified into volcanic breccia or volcanic lava flows based on their occurrence. Through analysis of their physical and chemical properties, we aim to assess their geothermal potential. Furthermore, the displayed core samples exhibit the presence of calcite veins, indicating that the fluids within the depth interval are neutral or weak acidic. It is confirmed that there might be a weak acidic reservoir in the subsurface of the volcanic geothermal field in Tatun volcanic group of northern Taiwan.

- 7. Future Mobility, Robotics and Automation


Product Summary

Regarding the working principles of the Digital Platform project of PMUC, we aim to promote digital innovation products/services at the global level. The four achievements of AI platforms developed by Thai researchers under PMUC's funding support are selected to join the event showcased.

- Kin-Yoo-Dee Platform by Burapha University: A comprehensive health and medical platform, which includes Personal Care & Family Care, Community & Corporate Health Check-ups (off-site health check-ups), Virtual Clinic & Telemedicine, and 24/7 Care Center Operation.
- 2. Waijung Software by Aimagin Co.,Ltd: A model-based design embedded system development platform that automatically generates C code from Simulink model files, compiles, and downloads the executable files to Espressif ESP32 and Xilinx Zynq-7000 targets.
- 3. ZTRUS OCR system by Accomate Co., Ltd.: A software solution that aims to provide automatic data entry service with OCR (Optical Character Recognition) and Al-based cognitive templates designed for various types of documents.
- 4. eNose by MUI Robotics Co., Ltd: eNose is a versatile and reliable tool, facilitating early detection of potential issues such as spoilage, or contamination. Its adaptability makes it a crucial asset for quality control processes in manufacturing, ensuring compliance with stringent standards.
